## NYC Muslim Communities and Supporters Seek Dignity, Respect, and Accountability from NYPD

New York, NY – Local City Council members and local and state representatives will join interfaith groups, civil rights leaders, Muslim and immigrant organizations, and a diverse group of concerned community members for a press conference in response to the NYC Police Department's use of a disturbing and prejudicial film to train officers working in Muslim communities in New York City.

As the Village Voice recently reported<sup>1</sup>, the NYPD used an offensive and discriminatory film about Islam and Muslims, *The Third Jihad*, as part of a training program, which would lead to increased racial and religious profiling. Given that this is not an isolated incident, but reflective of a problematic national trend exemplified by the recent and controversial Rep. Peter King hearings, use of biased instructors and materials<sup>2</sup>, and the systematic failure to regulate content in nationwide counterterrorism trainings<sup>3</sup>, community leaders believe the NYPD's actions present dangerously escalating consequences for the safety and constitutional rights of all New Yorkers. As New Yorkers, we object to the racial and religious profiling of all ethnic communities by law enforcement, including this recent targeting of Muslims.

MACLC, a coalition of community and civil rights organizations, has reached out to the NYPD, requesting full disclosure about curriculum and the process of selecting materials to train officers about Islam and Muslims, and the assurance that trainers and materials would be properly vetted in order to protect New Yorkers' collective safety and to avoid the profiling of Muslims. Commissioner Kelly's brief response stating that the video is no longer being used does not address any of our substantive concerns. This coalition, and concerned allies, seek further accountability to promote genuine safety, civil rights and dignity of all New Yorkers.
